Madras Saturday Market is a 501©6 non-profit organization registered with the State of Oregon. Fees collected are used for venue rental, and administrative costs, such as advertising and insurance.

All funds are used for the benefit of MSM. Board Members are unpaid volunteers. MSM Board reserves the right to terminate membership at any time if park and vendor rules are not followed by the vendor.

MEMBERSHIP

Annual membership fee is \$25.00 which covers vending between June 2023- Dec 31, 2023.

BOOTH FEES

10x10" space (with or without a canopy) \$25.00 per day/ for Seniors (60+): \$15.00 / for Non-profit organizations: \$10.00.

(collected weekly by the Market Manager)

MSM operates every Saturday from 10am -1pm, rain or shine. The market would only be closed for inclement / dangerous weather(high winds, heat or smoke warnings, lightning) or other health advisories. Attendance is optional, but I do ask that you let us know if you will not be at the MSM if we are expecting you.

City of Madras PARK RULES

- No smoking, drugs, or Alcohol in the park.
- No driving on the grass.
- No parking on B Street. It has a bike lane. Quick loading and unloading only.
- Pets must be on a leash
- do not dump handwashing water in the park

VENDOR RULES

- Be ready to sell promptly at 10am and remain set up until 1pm.
- Booths items must be hand- made, hand-crafted, or home-grown.
- NO IMPORTS OR RESALE ITEMS. Any questions please talk to the market manager.
- Vendor is responsible for providing the required insurance and license. MSM
- carries liability insurance for the park only but does not cover individual vendors, their products or booth.
- Vendors will move their vehicles out of prime parking areas after setting up. Please move your vehicle after you unload and before you start setting up.
- Vendors will secure canopies and awnings to prevent overturning during wind, or human interaction. Do not use Ground stakes, they are not allowed in park.
- Please use a minimum of 15lbs per leg on canopies.
- Vendors will not sell any drugs, ammuniton, weapons or related paraphernalia. All state, county and City laws are applicable.
- SOLICITATION, COLLECTION DRIVES, POLITICAL OR RELIGIOUS ACTIVITIES ARE NOT ALLOWED IN THE MARKET AREA. Our non-profit status prohibits it by law.
